PRIJAVE I REZERVACIJE BOKSEVA / ENTRIES AND BOX RESERVATION

- Prijave i rezervacije bokseva mogu se izvršiti isključivo putem službene web stranice turnira www.jumpingsamobor.com do **08.09.2025.** Cijena najma boksa iznosi 150,00 € neovisno o tome koristi li se jedan, dva ili sva tri dana natjecanja (dvije bale piljevine uključene u cijenu). Nakon slanja prijave, jahači će dobiti e-mail s podacima za uplatu avansa od 80,00 € po konju, te će **boksevi biti osigurani tek nakon slanja potvrde o uplati.** Štale se otvaraju 18.09. u 7:00 sati. Rezervacije otkazane nakon 07.09.2025. nemaju pravo na povrat avansa. U slučaju da do 08.09.2025. broj rezerviranih bokseva dosegne maksimalan kapacitet konja, nećemo biti u mogućnosti prihvatiti jednodnevne prijave bez rezervacije boksa, neovisno o datumu kada su poslane.
- Prijave za utakmice moguće je izvršiti u show office-u. Rok za prijavu je do 20:00 sati u četvrtak te do 18:00 sati u petak i subotu.
- **Prijave jahača i konja bit će priznate samo ukoliko posjeduju važeće licence Hrvatskog konjičkog saveza!**
- **Strani natjecatelji, članovi drugih nacionalnih saveza dužni su platiti godišnje gostujuće licence za hrvatska natjecanja, osim ako ih njihov matični savez ne naplaćuje hrvatskim natjecateljima. Ukoliko matični savez stranog natjecatelja naplaćuje gostujuće licence hrvatskim natjecateljima i konjima, hrvatske gostujuće licence naplatiti će im se u istom iznosu.**
- *Entries and box reservations can be made only through the official website www.jumpingsamobor.com until **08.09.2025.** The cost of renting a box is €150.00, regardless of whether it is used for one, two, or all three days of the competition (two shavings included in the price). After submitting the entry, riders will receive an email with details for the deposit payment of €80.00 per horse, and the **boxes will be secured only after sending the confirmation of the payment.** The stables will open on September 18th at 7:00 AM. Reservations canceled after 07.09.2025 are not entitled to a deposit refund.*
- *Entries for the classes can be made at the show office. The deadline is 8:00 PM on Thursday and 6:00PM on Friday and Saturday*
- ***Entries of riders and horses will be accepted only if the national federation of the rider has provided the necessary information to the Croatian Equestrian Federation!***
- ***Foreign competitors, members of other national federations, are required to pay annual guest licenses for Croatian competitions, unless their home federation charges them to Croatian competitors. If the home federation of a foreign competitor charges guest licenses to Croatian competitors and horses, they will be charged the same amount for Croatian guest licenses.***

- Svi natjecateljski konji moraju imati u putovnici konja upisani Coggins test (IAK) (ne stariji od godine dana) te biti redovno cijepljeni protiv INFLUENCE (ne starije od šest mjeseci) s datumom vidljivim u putovnici konja.
All competing horses must have a Coggins test (IAK) entered in the horse passport (not older than one year) and be regularly vaccinated against INFLUENZA (not older than six months) with the date visible in the horse passport.
- Organizator ne snosi nikakvu odgovornost za konje, natjecatelje i prateće osoblje, opremu, kao ni odgovornost prema trećim osobama.
